

## 60<sup>TH</sup> ANNIVERSARY CELEBRATION

**1. Eligibility:** No purchase or obligation necessary to participate and win. All participants must be 18 years of age or older at time of contest participation. Employees and volunteers of Del-One Federal Credit Union, their immediate families (spouses, parents, children and siblings, and each of their respective spouses), and members of the household of such individuals are not eligible to register for the contest.

Del-One Federal Credit Union will not be responsible for incomplete, lost, late, misdirected or illegible entries or for failure to receive entries. All entries become property of Del-One Federal Credit Union and none will be returned. Any questions regarding the number of entries submitted shall be determined by Del-One Federal Credit Union in its sole discretion, and Del-One Federal Credit Union reserves the right to disqualify any entries by persons determined to be tampering with, violating, or abusing any aspect of the contest.

**3. Contest Entry Requirements:** In the event the Credit Union, in its sole discretion, determines that any Entry contains content that does not comply with these Official Rules or does not otherwise comply with regulatory guidelines, the Credit Union reserves the right to disqualify the entry.

**4. Determining the Winner:** A Credit Union employee will select at random One (1) Winner from all entries received once per business day within the contest period. Winners will be announced via Social Media and contacted directly by a representative of Del-One Federal Credit Union.

**5. Prizes:** Each Winner will receive \$60 to be paid by direct deposit to a Del-One Federal Credit Union share account or by official check written to the name on the contest entry form. Only one winner per prize. Contestant can only win one Prize during the contest period. Prizes are non-transferable. Federal, state and local taxes are the sole responsibility of the winner.

A Credit Union employee will call the prize winner and the prize winner will be called up to three (3) times during regular business hours at the number provided on the entry form and will leave NO messages. The Credit Union will also send up to one (1) email to prize winner asking them to return a call to the credit union. Failure to reach winner during these calls or email may result in disqualification of winner, forfeiture of his or her interest in all prizes, and selection of a substitute winner drawn from the drum.
