## **Sweepstakes Rules**

Business, Trust, Estate, and other specialty title accounts are excluded from this offer.

- 2. How to Enter the Sweepstakes: There are two ways to enter the Sweepstakes:
  - a. Members who used their debit card more than twenty (20) times during the month of June will automatically receive (1) entry into the Sweepstakes.
  - b. An individual can enter the Sweepstakes once by:

Del-One will not be responsible for incomplete, lost, late, misdirected, or illegible entries or for failure to receive entries. All entries become property of Del-One, and none will be returned. Any questions regarding the number of entries submitted shall be determined by Del-One in its sole discretion, and Del-One reserves the right to disqualify any entries by persons determined to be tampering with, violating, or abusing any aspect of the Sweepstakes.

- **3. Determining the Winner:** A Del-One employee will select at random (1) winner each day during the week of July 07 July 11, 2025. Winners will be contacted directly by a representative of Del-One after each daily drawing.
